COMPLAINT


NOW COME Plaintiffs Joseph Bird, individually and T & J Towing, and for their Complaint against Defendant hereby states the follows:

3. That these apartment developments and business had previously contracted with Plaintiffs to remove vehicles which violated the owners' parking or use restrictions.




